

REGULATIONS GOVERNING PERSONNEL COMMITTEE OF INDIVIDUAL COLLEGES OR GRADUATE SCHOOLS OF SEOUL NATIONAL UNIVERSITY

Regulations No. 792, Mar. 12, 1990

Article 1 (Purpose)

The purpose of these Regulations is to provide for matters necessary for establishing and operating the personnel committee (hereinafter referred to as the "Committee") of individual colleges or graduate schools to conduct preliminary screening of matters concerning the appointment of faculty members, pursuant to Article 31 (7) of the School Regulations.

Article 2 (Formation)

- (1) The dean of a college or graduate school shall serve as Chairperson of the Committee; the vice dean of a college or graduate school shall serve as *ex officio* member; and the faculty council of each college or graduate school shall select other members and whom the dean of a college or graduate school shall appoint.
- (2) The dean of each college or graduate school shall obtain approval for the number of appointed members of the Committee from the President.

Article 3 (Chairperson)

The Chairperson of the Committee shall preside over the affairs of the Committee, and convene and preside over Committee meetings.

Article 4 (Preliminary Screening)

- (1) The Committee shall preliminarily screen matters concerning the appointment of faculty members belonging to each college or graduate school.
- (2) The Committee shall take the following into consideration when preliminarily screening candidates provided for in paragraph (1):
 1. Research and academic activities in the specialty area;
 2. Competence and achievement concerning teaching and guiding students;
 3. Adhering to education-related statutes and maintaining dignity as faculty member.

Article 5 (Meetings)

- (1) The Committee shall hold its meetings with at least two-thirds of incumbent members in attendance and pass resolutions with the concurrent votes of at least two-thirds of the members present.
- (2) The vice dean for academic affairs (in cases of a college that has one vice dean, referring to the vice dean) or the vice dean of a graduate school shall prepare minutes of the Committee meeting, and at least two attendees shall affix their signatures or seals thereto.

Article 6 (Reporting)

The dean of a college or graduate school shall report the details of screening and the outcomes thereof to the President in a specific form.

ADDENDA <Regulations No. 792, Mar. 12, 1990>

(1) (Enforcement Date)

These Regulations shall enter into force on the date of their promulgation.

(2) (Transitional Measures)

The former Regulations (Standing Rules) Governing the Committee on Personnel Management of Education Officials of _____ College or Graduate School are hereby repealed, the number of members of the Committee under the aforesaid Regulations (Standing Rules) shall be deemed approved pursuant to these Regulations, and the established personnel committee shall be deemed formed pursuant to these Regulations.
